

Amendment-I**KAMARAJAR PORT LIMITED***(A company of Chennai Port Authority)**[Ministry of Ports, Shipping & Waterways, Government of India]**Date: 13.10.2023***Amendment to “Waste Oil, Sewage & Other Wastes Reception Facilities Policy-2019”**

1. The empanelled recyclers are hereby informed to consider the dollar rate prevailing on the date of service provided (day of oily wastes removed from the ships) while paying the wharfage charges to the Port.
2. It is clarified that the day timings with regard to calculation of penalty charges will be considered as below.
 - *Day means ‘06:00AM of the present day to 05:59AM of the next day*
 - *After 06:00AM of the next day will be considered as 2nd day’ and so on.*

Accordingly, the wharfage & penalty charges are proposed to modify as below.

8	If the consignment taken out from port within same day	No charges till 24 hours.	No charges will be levied till one day. Day will be considered from 06:00AM of one day to 5:59AM of next day.
9	For any delay upto one day	No charges	No charges till one day. Day will be considered from 06:00AM of one day to 5:59AM of next day.
10	Delay beyond one day and upto two days	Rs.2000 per day + GST @18%	No change. Existing charges will prevail but the day time consideration (06:00AM to 5:59AM) will be applicable.
11	Delay beyond two days and upto 14 days	Rs.2500 per day + GST @18%	No change. Existing charges prevails but the day time consideration (06:00AM to 5:59AM) will be applicable.
12	Delay beyond 14 days	Leads to cancellation of empanelment and forfeit of security deposit there on.	No change.
